The Fund is managed by Gemini Capital Management (Ireland) Limited which acts as manager to the Company

Objectives and Investment Policy

The investment objective of the Fund is to seek to provide absolute growth through investments in a full range of global growth fixed income securities including, higher yielding corporate bonds with the aim of producing investment returns with a relatively high level of volatility (below 10% over a business cycle). It is envisaged that an important source of potential rise in the Fund's Net Asset Value will be through capital appreciation of the Fund, on top of the income stream generated by the coupons (or annual interest) on the bonds. "Absolute" in this context refers to the strategies' ability to use financial The Fund may use FDIs including exchange-traded futures, options and derivative instruments (FDIs) to protect the capital value of the Fund during periods of high market volatility.

The Fund is considered to be actively managed in reference to the ECB Deposit Facility Announcement Plus 3%, the Federal Funds Target Rate Mid-Point of Range plus 3% and the UK Bank of England Official Bank Rate plus 3% (the "Benchmarks") by virtue of the fact that it uses the Benchmarks for performance comparison purposes. However the Benchmarks are not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmarks.

The global fixed income securities, (which are securities that provide the Fund with a predicable income return, together with changes in its capital value) that the Fund will invest in may be fixed rate or floating rate and will be listed on one of more of the exchanges set out

in Appendix 2 to the Company's Prospectus.

The average credit quality of the Fund may be sub-investment grade(i.e. at or below S&P rating BBB- or equivalent).

A maximum of 20% of the portfolio may be held in fixed income securities that are denominated in emerging market currencies. The Fund may invest up to 10 % of its net assets in aggregate in other collective investment schemes.

The Company may, at its discretion, declare dividends (i.e. income arising from Shares will be paid out, subject to Directors approval).

Investors can buy and sell shares in the Fund on every business day meaning a day on which banks in Ireland and on which the relevant stock exchange is open for normal business subject to the 'Dealing Days for Subscription and Redemptions' and the 'Issue of Shares' and 'Redemption of Shares' section of the Supplement.

The following are risks materially relevant to the Fund which are not adequately captured by the indicator:

Credit Risk: There is a risk the bond issuer may fail to meet its repayments. This is usually a greater risk for bonds that produce a higher level of income. Changes in interest rates, inflation and the creditworthiness of the bond issuer may also affect the bond's market

Sub-Investment Grade Risk: Investment in sub-investment grade fixed interest securities involves greater price volatility and risk of loss of principal and income than investment in fixed income securities of a higher investment grade quality.

Derivative (financial techniques) Risk: The Fund is entitled to use derivative instruments for efficient portfolio management. Derivatives may not achieve their intended purpose. Their prices may move up or down significantly over relatively short periods of time which may result in losses greater than the amount paid. This could adversely impact the value of the Fund. The Fund may enter into various financial contracts (derivatives) with another party. There is a risk that this party will become insolvent or fail to make its payments which may result in the Fund and your investment suffering a loss. Where the Fund uses futures or forward foreign currency contracts (derivatives), it may become exposed to certain investment risks including leverage, market, mismatching of exposure and/or counterparty risk, liquidity, interest rate, credit and management risks and the risk of improper valuation. While the Fund is not expected to have exposure to leverage to a material degree, any movement in the price of these investments can have a significant impact on the value of the Fund and the Fund could lose more than the amount invested.


The ongoing charges figure is based on expenses for the year ending 31 December 2023. This figure may vary from year to year.
